# **Strategy and Roadmap**

Spotline team strategically aligned Veeva Vault implementation roadmap with organizational goals. Performed gap analysis and recommendations for process improvements. Created a migration strategy and planning for a seamless transition.

### **Implementation Services**

As a full-cycle Veeva Quality and eTMF implementation service provider, the Spotline team engaged with the customer for configuration and customization of Veeva Vault modules, designed and built integrations with existing line-of-business applications, provided GxP Validation services to ensure compliance with regulatory standards, and managed the end-to-end project for implementing various Veeva Vault modules.

# Post-Implementation and Application Managed Services

The Spotline team engaged in ongoing maintenance and support for Quality, eTMF, and RIM Veeva Vault environments. Performed regular updates (R1, R2, & R3 releases from Veeva), impact assessment, patches, and bug fixes keeping Veeva Vaults optimized. Created process for continuous improvements and enhancements to Veeva Vaults based on the new business requirements. Established a User support and issue resolution module to minimize disruptions. Work with IT and business stakeholders to ensure the continuous alignment of Veeva Vaults with ever-changing business needs.

### **Release Management Services**

As Veeva typically has three releases per year for continuous platform enhancements, and the customer has 2-3 additional releases for their specific configurations and processes, it's a costly and time-consuming process to keep up with the testing and validation for multiple vaults. Spotline team leveraged its V-Assure solution to automate testing and validation of their vaults. This reduced their testing cycles by ~80% and brought significant efficiency. Spotline team successfully established a very efficient and streamlined process for their multi-vault environment.
